Empower Youth Program: Every day in the United States, youth experience exploitation in many different forms, from bullying to trafficking. iEmpathize is committed to equipping youth to stay safe from exploitation. iEmpathize is also committed to equipping professionals who work with youth to know how to work preventatively with youth and to effectively recognize and respond to signs of exploitation. Youth must be empowered to navigate the factors in their lives that could otherwise make them vulnerable to exploitation. Our curricular tool - The Empower Youth Program - enables adults who are already working with youth to facilitate conversations about exploitation so that young people will be empowered with protective strategies. Since 2015, the Empower Youth Program has been ordered for use in over 120 schools and youth-serving organizations, in 20 different states, and has been licensed for over 14,000 youth. In 2016, CNN Freedom Project featured The Empower Youth Program and iEmpathize's partnership with the Male Leadership Academy in Long Beach, CA.

Be Relentless: Be Relentless is iEmpathize's outreach program, designed to educate and inspire communities to promote and implement The Empower Youth Program. Be Relentless is iEmpathize's first full-length documentary which follows mother, survivor, and ultra-athlete, Norma Bastidas, as she completed the World's Longest Triathlon. Norma made this journey to empower survivors worldwide by demonstrating that one's past does not dictate one's future. Ultimately, her accomplishment is a demand that we prevent what happened to her from happening to others. Be Relentless is a film and human rights campaign, with a call to action to distribute The Empower Youth Program. The film will engage and empower audiences like never before, encouraging empathy and understanding between Mexico and the United States, two countries connected and divided by a shared border. In this unique and urgent time, the problem of human trafficking can only be solved when countries work together; Be Relentless is a catalyst for this collaboration. Proceeds will fund prevention and restoration efforts benefitting vulnerable and victimized children. In 2016, we wrapped production on Be Relentless, held several test screenings in Denver and Los Angeles, and began submitting to film festivals around the world. Additionally, iEmpathize became a member of Creative Vision's Creative (Continued on Schedule O, Statement 1)

Empower Adults: In 2016, we continued to promote our other education and outreach programs, which include Adult Training and Workshops and The Apathy Effect Exhibit; both with a call to action to promote and implement The Empower Youth Program. iEmpathize trained over 800 adults in 2016 to know how to work preventatively with the youth they serve. The Apathy Effect Exhibit is a multi-media exhibit and empowerment program geared to ignite empathy and educate and empower participants with a response to issues of exploitation. The Exhibit immerses you in stories of resilient young survivors of human trafficking from around the world. The multimedia journey is told through original film, photography, and artifacts with self-guided or interactive tours adding to the experience. In 2016, The Apathy Effect Exhibit partnered with community organizations, businesses, and Universities throughout the U.S. The Exhibit was experienced by over 600 people at events in Colorado, California, Missouri, and Michigan.
